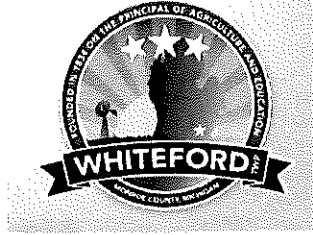

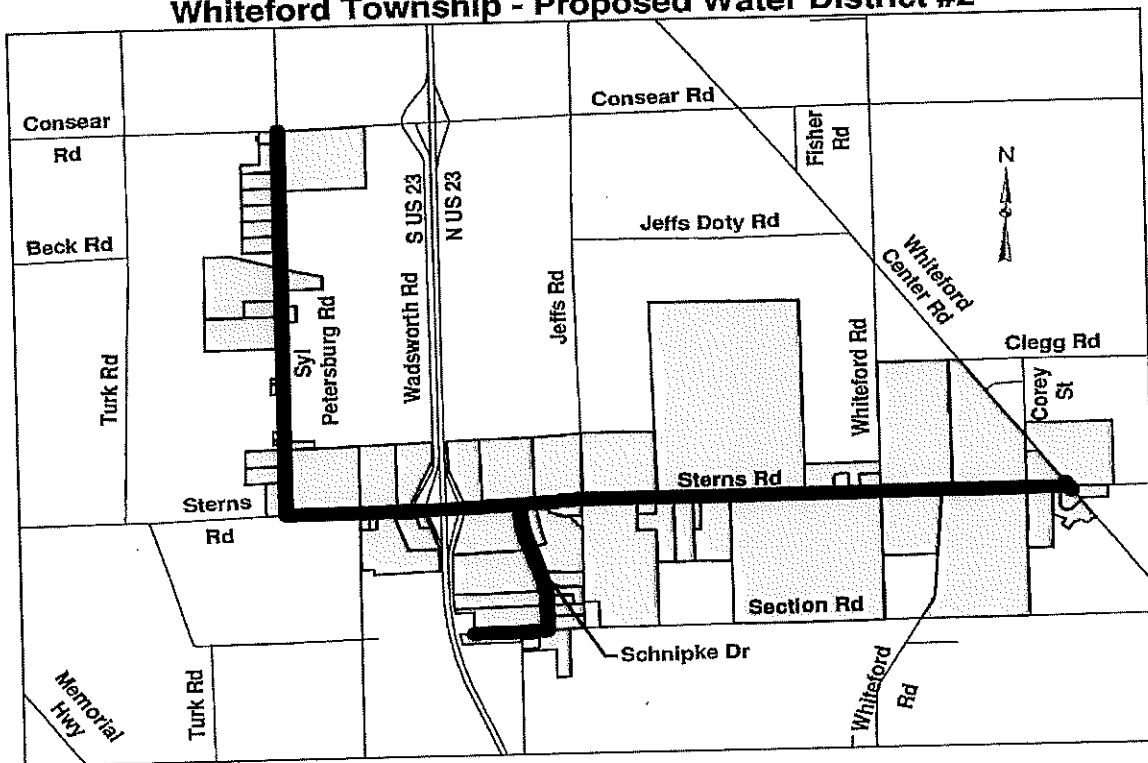

**NOTICE OF HEARING ON SPECIAL ASSESSMENT
IMPROVEMENTS BY THE TOWNSHIP BOARD OF
THE TOWNSHIP OF WHITEFORD**

TO ALL OWNERS OF THE
FOLLOWING-DESCRIBED LANDS:

Whiteford Township - Proposed Water District #2



TAKE NOTICE that pursuant to the provisions of Act 188, Public Acts of Michigan, 1954, as amended, the Township Board has tentatively declared its intention to proceed with the public improvements described as follows:

The acquisition, construction, furnishing and equipping of a municipal water supply system, consisting generally of an eight inch supply well, pumps, water mains, filtration, treatment, storage, distribution and transmission systems, together with all necessary interests in land, appurtenances and attachments thereto.

TAKE FURTHER NOTICE that the Township Board has tentatively declared its intention to make such improvement and tentatively designated the above-described lands as a special assessment district against which the cost of said public improvements is to be assessed.

TAKE FURTHER NOTICE that the Township Board has caused to be prepared plans showing the public improvements, the location thereof and an estimate of the cost thereof which have been filed with the office of the Township Clerk, 8000 Yankee Road, Ottawa Lake, Michigan, for public examination.

PUBLIC NOTICE IS HEREBY GIVEN that the Township Board will meet on Tuesday, the 6th day of July, 2021, at 7:30 p.m., Eastern Daylight Time, at the Township Offices, 8000 Yankee Road, Ottawa Lake, Michigan, to hear objections to the public improvements and to the proposed special assessment district therefor.

TAKE FURTHER NOTICE that the Township Board may determine to proceed to make said improvements without a petition unless written objections to the improvements are filed with the Township Board at or prior to the Township Board meeting to be held on Tuesday, July 6, 2021. If written objections are received from record owners of land constituting more than 20% of the total land area in the proposed special assessment district the Township Board may not proceed to make the improvements unless it first receives a petition requesting the improvements signed by the record owners of land constituting more than 50% of the total land area in the proposed special assessment district.
