

**ORDINANCE NO. 52  
PROHIBITING ALCOHOL ON TOWNSHIP PROPERTY**

An ordinance to prohibit the use, consumption, or possession of alcohol on Whiteford Township property.

**THE TOWNSHIP BOARD OF THE TOWNSHIP OF WHITEFORD, COUNTY OF  
MONROE, STATE OF MICHIGAN, ORDAINS:**

**Section 1 Alcoholic Beverages**

No person shall sell, furnish, dispense to another, nor possess or consume any alcoholic liquor, wine, beer or malted beverage within the boundaries of any property owned, leased or occupied by the Township.

**Section 2 Exemptions**

This section does not include the use of alcohol for sterilization purposes by the Township Fire Department.

**Section 3 Enforcement**

Any person violating any provision of this ordinance shall be deemed guilty of a civil infraction and upon finding of responsibility or conviction thereof be fined not more than \$100 and costs of prosecution for the first offense. If convicted of a violation of this ordinance within 5 years of a prior conviction of violating this ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof be fined not more than \$250 and the costs of prosecution and/or incarceration in the county jail for a period of thirty (30) days or both.

**Section 4**

All ordinances or parts of ordinance in conflict herewith are, to the extent of such conflict, hereby repealed.

**Section 5 Effective Date**

This ordinance or a summary of it shall be published as required by law, to become effective 30 days immediately following the date of publication.
