ORDINANCE NO. 59

TOWNSHIP OF WHITEFORD, COUNTY OF MONROE, STATE OF MICHIGAN ORDINANCE TO REPEAL OLD ORDINANCES AND RESOLUTIONS

The Township of Whiteford, Monroe County, Michigan ordains:

Section 1. Title

This Ordinance shall be known and cited as the "Ordinance to Repeal Old Ordinances and Resolutions."

Section 2. Purpose

The purpose of this Ordinance is to repeal, retire and update certain Whiteford Township ordinances and resolutions that are inconsistent with current Michigan statutes, codes and laws and to reinstate Ordinance 56 in its entirety.

Section 3. Ordinances and Resolutions Repealed and Retired

The following ordinances and resolutions of Whiteford Township, Michigan are hereby repealed and retired in their entirety:

Section 4. Reinstatement of Ordinance 56

Upon the effective date of this Ordinance and the repeal of Ordinance 56-A, Ordinance 56 shall be reinstated in its entirety as if said ordinance had been fully restated herein.

Section 5. Effect of Repeal

The repeal and retiring of said Ordinances and resolutions shall not have the effect of releasing or relinquishing any penalty, forfeiture, or liability incurred under said Ordinances or resolutions, or any part thereof, and such Ordinances and resolutions shall be treated as still remaining in force for the purpose of instituting or sustaining any proper action for the enforcement of such penalty, forfeiture or liability.

Section 6. Severability

If any provision, section, paragraph, sentence, clause or phrase of this Ordinance is for any reason found to be invalid or inoperative by a court of competent jurisdiction, it is hereby provided that such adjudication shall not affect, impair or invalidate the remainder of this Ordinance.

Section 7. Savings Provision

This Ordinance shall not affect pending litigation, either civil or criminal, founded upon or arising out of any ordinance, resolution, order, or parts thereof, hereby repealed; and this Ordinance shall in no manner affect any right, claims, privileges, immunities, or causes of action of the township, County, or any other person, either criminal or civil, that may have already occurred, accrued or arisen out of any ordinance, resolution, order or policy, or any part thereof, hereby repealed.

Section 8. Effective Date

The provisions of this Ordinance shall take effect thirty (30) days after publication.
